Dear Demson:

On behalf of KIK Pool Additives Inc., I am submitting a label notification per PR Notice 98-10 to make minor label changes and add graphics for the product KEM TEK KEMKLOR II, EPA Reg. No. 7616-45.

We are making the following minor label changes including: (changes are highlighted)

- Addition of the following Alternate Brand Names:
 - Bioguard Chlorinating Liquid
 - Desert Star Liquid Chlorinating Compound
 - Aqua Chem Balanced for Clean Pools Liquid Chlorinizor
- Minor revisions to First Aid statement to make the format consistent with the other KIK Pool EPA approved labels including EPA Reg. No. 7616-57, -58, -70, -73, -75, -76, -78. (See below for additional explanation.*)
- Addition of label claims (page 3-4)
 NOTE: On page 4, the highlighted "Notice: This product..." wording is not new, but was merged and moved for convenience of the registrant in preparing marketplace labels and notifying the States.
- Addition of minor optional language
- Addition of reader's note
- Addition of graphics (page 6)

*Background explanation:

The changes are to revise formatting and to make the repetitive language optional. EPA has approved the same first aid format/repetitive language changes on multiple KIK Pool labels as noted above, including as a notification. One of KIK's goals in revising its labels has been to standardize and make the KIK Pool labels consistent with each other so that a consumer could expect to see the same basic language and layout on the KIK Pool labels. The 7616-45 label is the only KIK Pool label that EPA approved with the repetitive First Aid language. The changes are minor (moving the "Call a poison control center... Have the product container" to a prominent position at the top of First Aid and removing repetitive and minor language.) We have added brackets to indicate the repetitive language is optional.


