On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Based on your response to the Reregistration eligibility Documents, EPA has reregistered the product listed above. This action is taken under the authority of section 4 (g)(2)(c) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Registration under this section does not eliminate the need for control reassessment of pesticides. EPA may require submission of data at anytime to maintain the registration of your product, with regards to labeling, you must make the labeling changes listed below:

1. Based on the Acute Toxicology profile for this product you must include a heading of "First Aid" or "Statements of Practical Treatment". The statements of practical treatment should be placed directly below the header "Precautionary Statements". First Aid statements should read as follows:

FIRST AID

"IF SWALLOWED: Call a physician or Poison Control Center immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told by poison control center or doctor.

IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment

IF ON EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first five minutes, then continue rinsing. Call a poison control center or a doctor for treatment advice."

2. The following statements should be placed near the First Aid Statements:

"Have the product container or label with you when calling a poison control center or going for treatment."

3. The "HAZARDS TO HUMANS" statement must be modified to read as follows:

"Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Prolonged or frequently repeated skin contact may cause allergic reaction to some individuals.

Personal Protective Equipment (PPE)

Mixers and Handlers must wear:

- -long-sleeved shirt and pants
- -shoes and socks
- -chemical resistant gloves."
- 4. A "User Safety Requirements" statement must be added to the label and should read as follows:

 The recommendations should read as follows: "Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry."
- 5. A "User Safety Recommendations" statement must be added to the label and should read as follows:
 Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.
 Users should remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Users should remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing."
- 6. While this product is toxic to fish, it is not necessary to make the statement: "Do not contaminate water when disposing of equipment wash water."
- 7. Under the heading "Directions for Use", add the statement: "Feeds with this product should not be pelleted or mixed with feeds containing predominantly pellets. This product should not be mixed with liquid feed supplements."

Feed STOCKADE Fly Control Mineral Mix free choice at the rate of 4 ounces per 1,000 pounds of body weight per head per day or by mixing it into the ground grain or complete daily ration. STOCKADE Fly Control Mineral Mix may be fed up to slaughter and to lactating dairy cows. Start feeding STOCKADE Fly Control Mineral Mix early in the spring before flies begin to appear and continue feeding throughout the summer into the fall until cold weather restricts fly activity.

STOCKADE Fly Control Mineral Mix prevents the development of horn flies, face flies, house flies and stable flies in the manure of treated cattle but is not effective against existing adult flies. When starting a feeding program during the fly season, it is desirable to use other control measures to reduce the population of existing adult flies.

In some cases, supplemental fly control measures may be needed in and around cattle lots and buildings to control adult house flies and stable flies which can breed not only in cattle manure but in other decaying vegetable matter or silage on the premises.
