DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with labeling.

ALGAE CONTROL: Break open pouch and squeeze one tablet into 50 gallons of water. Remove algae mechanically before treatment and agrate water after treatment. Treatment effective for several weeks depending on conditions causing algae growth. Repeat when algae reappear. For heavy growth, it may be necessary to repeat treatment in 6 days.

PRECAUTION: Treatment may injure water hyacinths and water lilies. See explanation below to determine gallon capacity of fishpool. Distribute tablets uniformly throughout the fishpool.

RECTANGULAR OR SQUARE POOLS: Multiply length times width times average depth; then multiply result by 7.5. This will give the approximate number of gallons to treat.

CIRCULAR POOLS: Multiply the diameter by itself. Then multiply this number by the average depth. Multiply this total by 5.9 to get gallons treated,

IRREGULAR SHAPED POOLS: Multiply the long diameter by the short diameter. Multiply the total by the average depth, and this total by 5.9 to get the number of gallons treated.

STORAGE AND DISPOSAL

Store in a dry place. Do not contaminate water, food, or feed. Do not reuse container. Wrap container and put in trash collection.
