The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance

Use other control measures to reduce the existing adult fly population. In order to achieve optimum fly control, use SWEETLIX 16:8 Free Choice Mineral with RABON Oral Larvicide in conjunction with other good management and sanitation practices. Start feeding SWEETLIX 16:8 Free Choice Mineral with RABON Oral Larvicide in early spring before flies begin to appear and continue feeding throughout the year until cold weather restricts fly activity. SWEETLIX 16:8 Free Choice Mineral with RABON Oral Larvicide may be fed to cattle up until slaughter and to lactating cows.

This product is a cholinesterase inhibitor. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine.

Product may cause aspiration pneumonia. Probable mucosal damage may contraindicate the use of gastric lavage.

Hazards to Humans & Domestic Animals

[Use Restriction: Not to be used on horses destined for slaughter.]

[Precautions for Horse Use: This product contains Tetrachlorvinphos, which is a cholinesterase inhibitor. The most frequently reported clinical signs of cholinesterase inhibition in the horse are abdominal pain, lethargy, sweating, tearing and excessive salivation. If these signs are seen in horses, immediately consult your veterinarian. Do not use this product simultaneously or within a week before or after treatment with cholinesterase inhibiting drugs, pesticides or chemicals. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals. This product has not been tested in breeding horses.]

Feeding Instructions

Feed SWEETLIX 16:8 Free Choice Mineral with RABON Oral Larvicide continuously on a free choice basis to cattle [and [or] horses]. Feed as the only free choice source of salt, minerals or vitamins. Feed SWEETLIX 16:8 Free Choice Mineral with RABON Oral Larvicide at a level to provide 70 mg RABON® per 100 lbs. of bodyweight per day (2.1 grams per 100 lbs. bodyweight per month). Use the table below to determine proper intake levels to deliver the required 70 mg RABON® per 100 lbs. of bodyweight per day:

If animals consume more or less than these levels, feeders should be moved further from or closer to the general loafing or watering areas. If animals still fail to consume the correct amounts, discontinue feeding this free choice supplement. Provide fresh, clean water to all animals at all times. **Follow feeding directions**. Consumption of selenium should not exceed 3 mg per head daily.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in a cool, dry place in the original container. **Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **Container Handling:** Nonrefillable container; do not reuse or refill this container. Offer for recycling, if available. Dispose of empty container in a sanitary landfill or by incineration, or if allowed by state or local authorities, by burning. If burned, stay out of smoke.
