DIRECTIONS FOR USE

PENTA GENERAL WEED KILLER is a general contact herbicide. As such it kills to the ground all vegetation properly sprayed with it. The entire leaf and stem surfaces of the weeds and grasses to be controlled should be covered with the spray. This will require between 0.5 and 1.5 gallons of spray per 100 square feet, depending upon the height and density of the vegetation.

Shallow-rooted annual weeds that are thoroughly sprayed will generally be completely killed. Perennial weeds will be killed to the ground but in many cases will re-sprout. In areas of low rainfall, control will be good if the weeds are sprayed when they are full size and when the time of sparse rainfall begins. Repeated spraying whenever new growth appears from seeds germinating later in the year or from re-growth of established weeds may be necessary in order to achieve desired control.

APPLICATION INFORMATION

Use oil resistant synthetic rubber hoses and gaskets. Wash out the sprayer after use with water and a synthetic detergent.

Either cone or fan shaped nozzles may be used for applications. In tall, dense weed growth it is best to use a fan shaped nozzle and a pressure of at least forty pounds per square inch to aid in reaching the lower parts of the weeds. Spray nozzles should not cause atomization as the spray will then drift and may cause injury to nearby valuable vegetation.

CONTAINER DISPOSAL: Do not re-use empty drum. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place away from water supplies.

DIRECTIONS FOR USE:

Dilutions with water: For dense growth, including tall weeds such as Johnson grass or pigweeds, add one volume of PENTA GENERAL WEED KILLER to five volumes of water.
