2. The labels which will be used for this product in channels of trade must reflect these revisions.
3. Five copies of the finished printed labels, as defined in the A-79 enclosure, must be submitted to the Agency before the product is released for shipment to comply with PR Notice 82-2 of June 18, 1982.
4. The finished printed labels must comply with the general labeling requirements of Section 162.10 of Title 40 of the Code of Federal Regulations. If the label does not satisfy these requirements it will be rejected.

THIS DISINFECTANT is effective against a wide variety of gram-positive and gram-negative bacteria. It is also an excellent deodorant and is especially effective in controlling odors that are bacterial in origin.

THIS DISINFECTANT mixes with water to form clear, stable use solutions. Use solutions are non-corrosive and non-staining to plastic, vinyl, synthetics, enamel, tile and most common metals. Has a pleasant pine odor.

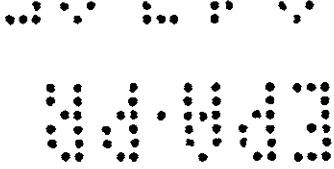
