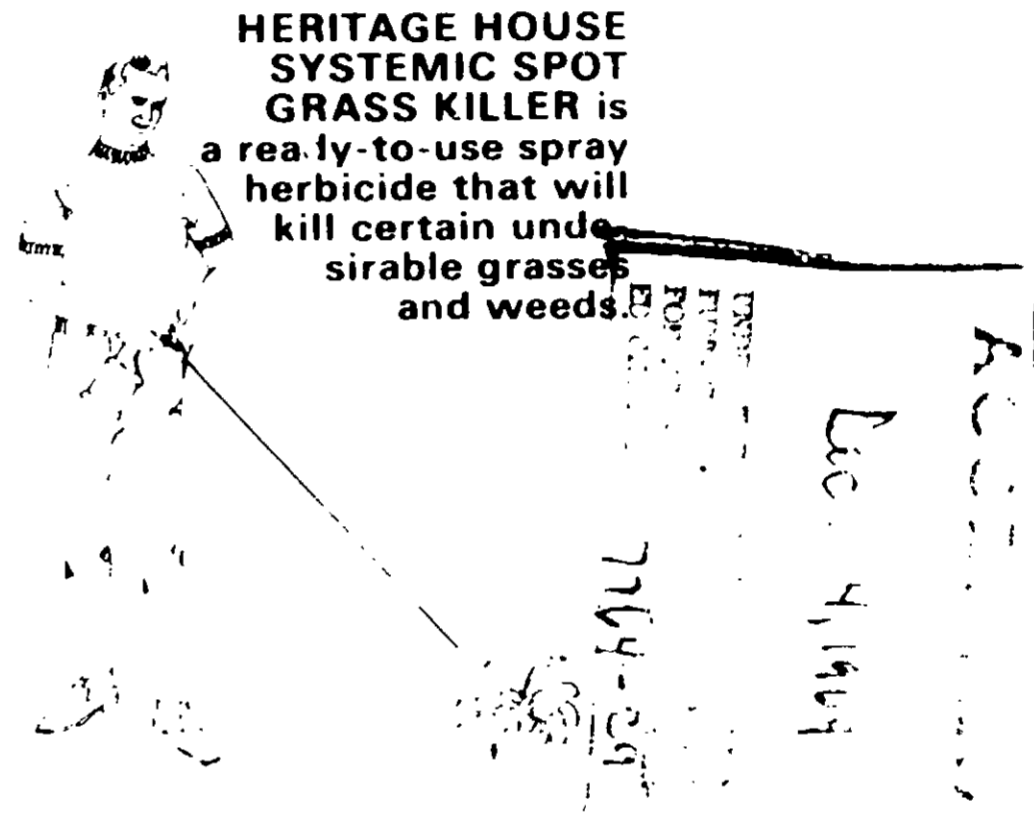

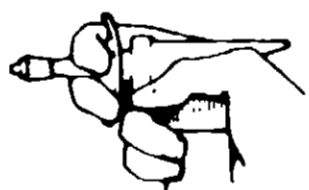

### DIRECTIONS:

Turn trigger to left to unlock.



Hold sprayer as shown. Squeeze trigger with index and middle fingers.

Turn adjustable nozzle by rotating to deliver a coarse, wet spray, or jet stream. Coarse sprays are less likely to drift.

**EASY AND ECONOMICAL TO REFILL!** Just unscrew gun and refill with HERITAGE HOUSE SPOT GRASSY WEED KILLER CONCENTRATE. Contains 2 refills.

**WHEN TO USE:** Weeds and grasses can be killed any time during the growing season. However, they are most easily killed during periods of rapid growth. For best results apply when:

- (1) Temperature is moderately cool — preferably below 80°
- (2) There is little or no wind
- (3) No rain is expected for 8 hours
- (4) The soil is moist. Late afternoon is the preferred time for treatment

**HOW TO USE:** For use on lawns: Spot treatment only. Do not apply over entire lawn. Injury to turf will result. Use as is, no further dilution necessary. Spray the clumps of coarse fescue, water grass, nut grass, goose grass and certain other undesirable grasses and weeds thoroughly to the point of run-off. Adequate coverage and complete wetting of foliage is very important. Best results are obtained by foliar absorption, run off should be minimized. Repeat application if regrowth occurs. Avoid spraying desirable grasses. No need to dig up dead plants.

Treated areas can be re-seeded within three weeks. For use on patios and driveways: For spot treatment. Use as is, no dilution necessary. Spray the unwanted grasses and other weeds thoroughly to the point of run-off. Adequate coverage and complete wetting of foliage is important. Repeat application if regrowth occurs.

**CAUTION:** Do not use on newly seeded lawns until after third mowing. Do not re-seed lawns until 3 weeks after last application. Do not reuse empty container or sprayer for other purposes. Wash thoroughly with water and detergent. Discard in a safe place.

**WARNING:** Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Wash hands after using. In case of contact, wash immediately with soap and warm water. For eyes, flush with clear water and get medical attention. Avoid inhalation of vapors or spray mist. Keep children and animals off treated areas. Avoid contamination of feed, foodstuffs, streams or other water sources. Do not spray or allow spray to drift on desirable flowers, trees, shrubs or vegetables. Do not store near fertilizers, seeds, insecticides or fungicides. Keep out of reach of children and domestic animals.
