Your letter dated July 14, 1990 which provided revised labeling to comply with the Allethrin Registration Standard. Your letter dated April 19, 1990 which prompted a revised confidential statement of the new EPA and replacement for dinitronaphthalene, prior to issuance of toxicological comments.

In response, I am sending, instead CCP and replacement statement, not submitted in connection with registration of the Insecticide, Fungicide and Rodenticide, or otherwise, in its entirety provided you make the following changes to your next set of printed labels:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Every set consists of two coils.

- 1) Separate the coils with care. Hold the comma-shaped end of one of the coils between two fingers as shown in the illustration. Shake it lightly over the palm of the other hand and it will be easily separated.
- 2) Use one coil at a time by placing it on the metal stand provided in the box. Insert the holder tip into the hole at the center. The light the outer end of coil.
- 3) Any broken piece of coil may be used by inserting in open gap in holder as illustrated.

Mosquitoes will be repelled when used as directed on porches or similar areas where there is little air movement.
