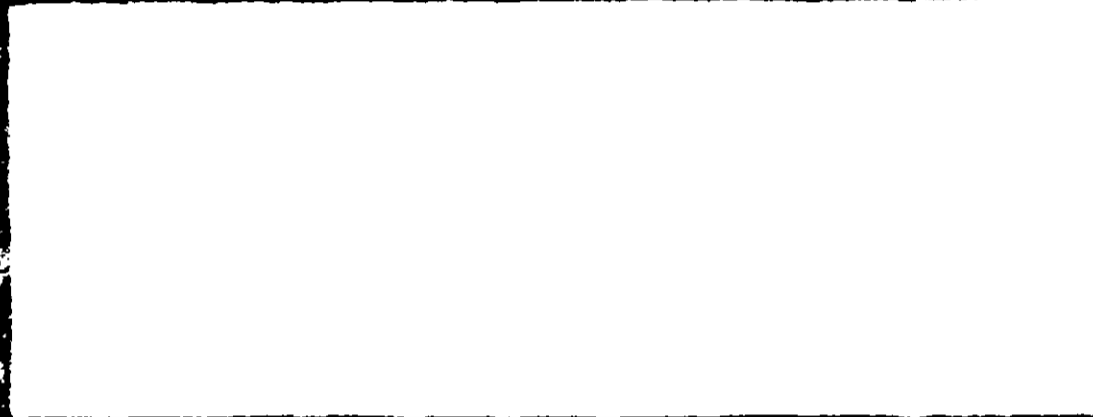



NEWLY SEEDED

1. Apply contol

lawn when application is made approximately 2-3 weeks before crabgrass appears. It is, therefore, suggested that application be avoided during February or early March.

NEWLY SEEDED LAWNS

1. Apply contents evenly over 5,000 square feet immediately after seeding (1.6 lbs. per 1,000 sq. ft.)
2. Provide sufficient moisture to insure germination of new grass seed.
3. An application of Lawn Life Turf Food is recommended after new turf is growing well.

ESTABLISHED, OVERSEEDED OR PATCHED LAWNS

1. Apply contents evenly over 2,500 square feet before crabgrass germinates (3 1/8 lbs. per 1,000 sq. ft.)
2. For best results, the lawn should be watered thoroughly soon after application.
3. Application of Lawn Life Turf Food is recommended in the Summer and Fall.
