The amendment referred to above submitted in connection with registration under FIFRA is acceptable, provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a. Modify the Protective Equipment Statements to read as follows:

When applying this product - wear goggles or face shield, chemical resistant gloves, coveralls or long legged pants, socks, and long sleeved shirt. When mixing or loading or when adjusting, repairing or cleaning equipment wear chemical resistant gloves extending above the wrist, a chemical resistant apron, long legged pants, socks, and long sleeved shirt.

- b. On the labeling for "Ronilan FL Turf Fungicide" (EPA Reg. No. 796-2) add the statement:

Do not enter treated area without protective clothing until sprays have dried.

- c. For the flowable formulation, delete the reference to wettable powder above the ingredients statement.

- d. For both labels, change the last sentence under Environmental Hazards to "Do not contaminate water when disposing of equipment washwaters." Add "This product is toxic to fish."

2. Submit one (1) copy of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.

For your assistance enclosed is a copy of the Non-Dietary Exposure Branch's review.
