There does not appear to be a tolerance established for use of sethoxydim on "pome fruits" as listed on the label. Tolerances have been established only for apple pomace. The label must be revised.

- 4) Per the acute toxicity review, the "IF SWALLOWED" statements must be revised to read:
- "IF SWALLOWED:
Immediately call a poison control center or doctor.
Do not induce vomiting unless told to by a poison control center or doctor.
Do not give any liquid to the person.
Do not give anything by mouth to an unconscious person."
- 5) Per the acute toxicity review, a Note to Physician must be added to the label and must read:
"Note to Physician May pose an aspiration pneumonia hazard. Contains petroleum distillate."
- 6) To the storage and disposal section of the label:
-Add text under the Container Disposal heading that describes and identifies the container as refillable or nonrefillable.
-Revise the heading "Container Disposal" to read "Container Handling."
- 7) Add "or rinseate" after "washwaters" (to the Environmental Hazards section).

Submit one copy of the revised final printed label for the record. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e).
