Your Application Dated April 29, 1997

The amendment referred to above, submitted in connection with registration under section 3(c)(7)(B) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is conditionally registered provided that you:

1. Satisfy data requirements of 40 CFR 158.290, Guidelines Reference No. 165-1 - Rotational crop confined accumulation study (39 months) within five(5) years from the date of this registration notice.

2. In accordance with section 408(b)(2)(E)(ii) of the Federal Food, Drug, and Cosmetic Act (FFDCA), the Agency is requiring, pursuant to subsection (f)(1), that data be provided five years after the date on which the tolerance is established, modified, or left in effect, and thereafter as the Administrator deems appropriate, demonstrating that such residue levels are not above the levels so relied on. If such data are not so provided, or if the data do not demonstrate that the residue levels are not above the levels so relied on, the Administrator shall, not later than 180 days after the date on which the data were required to be provided, issue a regulation under subsection (e)(1), or an order under subsection (f)(2), as appropriate, to modify or revoke the tolerance.

The proposed labeling you submitted for each product is acceptable. Note that for Ronilan 50 DF, the ten(10) day reentry interval (REI) on the label may be reduced to three(3) days. Submit three copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
