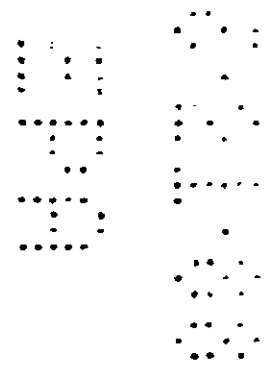
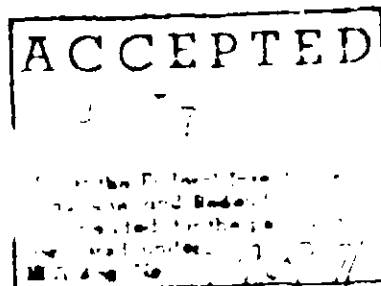

Pesticide Storage
