Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

- a. The third sentence of the Precautionary Statements must be moved to the position of the first sentence.
- b. Since this product has been shown to be a dermal sensitizer, the following statement must be included in the Precautionary Statements:

"Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."

2. The Statement of Practical Treatment must state as follows:

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF IN EYES: Flush with plenty of water. Call a physician if irritation persists.

- d. In the resultry statement, change "Warning" to "Caution" to consort with the product signal word.
- e. Und a high polimental Hazards, change the second sentence to: "Do not happy directly to water, to areas where surface

water is present or to intertidal areas below the mean high water mark."



#### General information

Ronitan\* DF fungicide is effective on all turfgrasses for control of Dollar Spot, (Sclerotinia homoeocarpa; Lanzia sp.; Moelleradiscus sp.J. Helminthosporium Leaf Spots and Melting Out (Drechslera spp.; Bipolaris sp.J., Pink Patch and Red Thread Limonomyces roseipellis and Laetisaria fuciformis, respectively), Gray Snow Mold (Typhula spp.), Fusarium Patch and Pink Snow Mold (Fusarium nivale; Microdochium sp.), Anthracnose l Colletorrichum graminicola J, and Brown Patch (Rhizoctonia solani). To maintain the health of your turf, it is recommended that turfgrass be protected against infestation of these diseases. preventive application of Rondan DE should occur before the disease is expected to appear. If this cannot be done, make curative applications according to the Application Rates and Timing Table for disease to be controlled.

Thoroug erage of all foliage is import to enough spray volume and pressure must be used to achieve desired disease control. Apply indicated rates of **Ronilan DF** in 2-4 gallons of water per 1,000 sq. ft. (80-160 gal./acre) of turf after moving and allow foliage to dry before irrigation

Mixing instructions

Fill spray tank with 1/2-3/4 of total water volume required and start agitation system. Jet or mechanical agitation must be provided during filling and application to ensure adequate dispersion/suspension of product. Add proper amount of **Ronilan DF**.

Complete filling to the desired volume. Keep agitated to ensure even suspension of material. Make fresh daily. Spray uniformly over the area to be treated with a properly calibrated power sprayer equipped with nozzle screens and inline strainers no finer than 50 mesh. Rinse tank, screens, nozzles thoroughly prior to and following application. Do not apply this product with spray equipment not having

jet or mechanical agitation.

#### Tank mixes

For the additional control of brown patch and anthracnose, Ronilan DF may be tank mixed with Fungot, systemic turf fungicide. When this or other products are to be tank mixed, a tank mix compatibility test should be conducted to ensure compatibility under local spray conditions. Due to variability within species, application equipment and the number of possible tank mix combinations, neither the manufacturer nor the seller has determined whether or not Ronilan DF tank mixes not listed on this labeling can be safely used on all turf sites. lank mix product should time the following sequence one tank has been ½-¾ filled and agitation has been started:

- Add wettable powders to the tank first, allowing them to completely suspend in the tank before proceeding. This process can be hastened by premixing the product in water before adding to the tank.
- 2. Add flowables (Ronilan\* DF fungicide) or suspensions next.
- 3. Add emulsifiable concentrates last.
- Add the remaining amount of water. Do not leave tank mix combinations in the spray tank for prolonged periods without agitation. Mix and apply the same day.

Tank mix compatibility test
Any other product that is to be
used with Ronilan DF should be
checked for compatibility. Using a
quart jar, check the compatibility
of the product using the following
procedure:

- Use only water from intended source and at the source temperature. Fill the jar ½-¾ full.
- Add ¼ oz. (1½ teaspoon) of Ronilan DF to the water for each 1 oz./1000 sq. ft., or, if a liquid, 1 teaspoon for each pint of recommended rate.
- 3. Add the remaining water in the jar, cap, invert for 10 cycles and let stand for 15 minutes. An ideal tank mix combination will be uniform. The compatibility is questionable if there are any oil film or globules on the surface, fine particle flocculation in the liquid or at the bottom, or clabbering—thickening of the liquid resembling yogurt or a curd-like texture as with cottage cheese.
