"Do not induce vomiting or give anything by mouth to an unconscious person."

c. In the paragraph under Hazards to Humans and Domestic Animals, insert the word "protective" in the statement regarding eyewear so that it reads "Wear protective eyewear (goggles, face shield, or safety glasses)."

d. Add the following dermal sensitization statement to the Hazards to Humans and Domestic Animals section:

"Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."
