d. As outlined in Pesticide Regulation (PR) Notice 93-10 add to ENVIRONMENTAL HAZARDS:

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

IF INHALED: Remove viction to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

3. Submit two copies of the revised final printed label before you release your product for shipment.


