

Instructions for Infurrow Use to Aid in the Control of *Rhizoctonia solani* seedling disease in Corn, Cotton, Soybean, and Sugar beet

Application Directions. Use 0.1 to 0.8 fl oz of **Headline** per 1000 feet of row. Refer to this chart to determine the rate per acre. Apply at planting as an infurrow application by directing the spray into the furrow before seed is covered. Use a minimum volume of application of 2.5 gallons of water per acre.

When *Rhizoctonia solani* seedling disease pressure conditions are expected to be severe or if the field has a history of seedling diseases, use **Headline** at a product rate per acre equivalent to 9 to 12 fl ozs and/or tank mix with a fungicide having a different mode of action.
