

Directions For Use

It is a violation of federal law to use this product in a manner inconsistent with this labeling. General Information

Promot^e 5L herbicide is intended for the posternergence control of a broad spectrum of broadleaf weeds in turf. Prompt 5L does not control grasses. Prompt 5L is effective mainly through contact action; therefore, weeds must be thoroughly covered with spray. Large leaf canopies shelter smaller weeds and prevent adequate spray coverage. The desired plants recommended for use in this labeling are tolerant to Prompt 5L when used as directed. Very slight leaf speckling of desired plants may occur but these plants generally outgrow this condition.

Timing of Applications
Apply Prompt 51, early posts

Apply **Prompt 5L** early posternergence when weeds are small and actively growing and before weeds reach the maximum size listed in the **Application Rate Table**.

Early application to weeds produces the most beneficial effect on weed control, allows use of the lower rate (depending on weed species) and makes it easier to obtain thorough spray coverage. Delay in application which permits weeds to exceed the maximum size stated will result in inadequate control.

Water Volume and Spray Pressure

Apply recommended rates of **Prompt 5L** as follows: **Ground equipment:** Use a minimum of 20 gallons of water per broadcast acre and a minimum of

mum of 20 gallons of water per broadcast acre and a minimum of 40 psi pressure (measured at the boom or hand gun, not at the pump or in the line). When weed foliage is dense use up to 50 gallons of water and up to 80 psi pressure. Use standard high pressure pesticide hollow cone, flat fan nozzles, or hand gun for best weed coverage.

Hand Sprayer Mixing

Add 0.5-0.85 fluid ounces of **Prompt 5L** to 1 gallon of water. One gallon of mix should cover a maximum of 1,000 square feet. Shake or stir the spray solution so the **Prompt 5L** and water mix well. Shake periodically while spraying.

Mix only enough spray solution for one usage. A fresh spray mix should be used each time.

Special Information on Irrigation In irrigated areas, it may be necessary to irrigate prior to treatment with Prompt 5L to ensure weeds are growing actively. Weeds growing under drought conditions usually are not satisfactorily controlled, so it will be necessary to irrigate these areas before application or wait until adequate rainfall has been received.

Nonfood uses Turf

For use in Bermudagrass, St. Augustinegrass, zoysia and centipedegrass. Apply no earlier than 10 days after sprigging or plugging. On newly sprigged turfgrass and hybrid bermudagrass, temporary slowing of growth and yellowing may occur following application.

Special Directions for Other Weed Problems

Canada thistle

Apply Prompt 5L at 2²/s pints per acre (0.88 fluid ounces/1,000 square feet) when plants are from 8-10 inches tall to the bud stage. Make a follow-up application 7-10 days later using the same rate of Prompt 5L, or use Basagran* herbicide at 2 pints per acre (0.75 fluid ounces/1,000 sq. ft.).

Yellow nutsedge

A single application of **Prompt 5L** at 22/5 pints per acre (0.88 fluid ounces/1,000 square feet) will provide suppression of yellow nutsedge. For control of yellow nutsedge apply **Prompt 5L** at 22/5 pints per acre (0.88 fluid ounces/1,000 square feet) when plants are 1-4 inches tall. Make a follow-up application 7-10 days later using the same rate of **Prompt 5L** or use **Basagran** at 11/2-2 pints per acre (0.55-0.75 fluid ounces/1,000 square feet).

Field bindweed

For suppression of field bindweed apply **Prompt 5L** at 2²/5 pints per acre (0.88 fluid ounces/1,000 square feet) when field bindweed vines are 8-10 inches long.

Tank Mixing with Prompt 5L
For additional nutsedge, Canada
thistle, or bindweed control, Prompt
5L may be tank mixed with
Basagran® herbicide. Use
Basagran at 1-1.5 pints per acre
(0.37-0.55 fluid ounces/1,000
square feet) when used in this tank
mix.

Restrictions and Limitations
Do not apply Prompt 5L when
desired plants are under stress from
prolonged cold, wet weather, poor
fertility, or other factors.

Do not apply **Prompt 5L** if desired plants show injury (leaf phytotoxicity and/or plant stunting) produced by any other prior pesticide applications, because this injury may be enhanced and/or prolonged.
