Subject: Revised Confidential Statement of Formula and Labeling; Change in Source of Active Ingredient Mecoprop AK Technical Acid EPA Registration No. 7969-127 Your Submission Dated January 31, 2001

The Agency has reviewed your submission for the revised Confidential Statement of Formula dated February 1, 2001 for the basic formulation. It has been determined that the Confidential Statement of Formula agrees with the label claim in compliance with PR Notice 91-2 and is acceptable. The Confidential Statement of Formula has been added to your file as part of the record.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

1) Revise the third sentence in the Precautionary Statements to read "Harmful if swallowed, inhaled, or absorbed through skin." In addition, add the statement "Avoid breathing dust."

2) In order to comply with PR Notice 2001-1, revise the Statement of Practical Treatment so that it reads as follows. In addition to the following language, it is encouraged that you add an emergency phone number.

FIRST AID					
If in eyes:	 Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. 				
If swallowed:	 Call poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything by mouth to an unconscious person. 				
If on skin or clothing:	 Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. 				
If inhaled:	 Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
