The PPE text may remain on the label.
 - b. Under First Aid, add the "If Inhaled" statement below the "If in Eyes" statement to read as follows: "If Inhaled
 - Move person to fresh air.
 - If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth-to-mouth, if possible.
 - Call a poison control center or doctor for further treatment advice."
