

## Lay-by Applications for Use in Field Corn, Seed Corn and Popcorn

EPA Reg. No 7969-147

### Directions For Use

It is a violation of federal law to use this product in a manner inconsistent with its labeling. All applicable directions, restrictions, precautions and **Conditions of Sale and Warranty** on the EPA-registered label are to be followed. This labeling must be in the possession of the user at the time of application.

### General Information

**Frontier 6.0** may be used in lay-by applications for control of late season germinating weeds in corn (field, seed, pop). Lay-by applications are made when corn is greater than 8 inches tall but before it is greater than 36 inches tall. Applications must be made before weeds emerge from soil or in combination with a herbicide(s) and/or cultivation that controls emerged weeds. For best performance direct applications beneath the corn canopy. For specific use rates by soil type, refer to the **Frontier 6.0** container Directions For Use label. Lay-by applications may be made to soil previously treated with **Frontier 6.0** but must not exceed a total combined rate of 32 fluid ounces of **Frontier 6.0** per acre.

Corn may be grazed or fed to livestock 40 days or more after lay-by application of **Frontier 6.0**. Do not make lay-by applications of **Frontier 6.0** to sweet corn.
