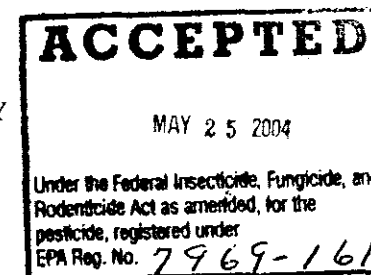

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with this labeling.

This product is for **FORMULATING USE ONLY** into EPA registered Antimicrobials for the following uses: As a preservative of industrially prepared water based suspensions (pigment and mineral slurries, adhesives, polymers and starches) as an antimicrobial in oilfield operations (drilling muds, packer fluids, process waters and pipeline and tank maintenance); for the preservation of clay slurries, adhesives, coatings and high viscosity suspensions; for control of algae, fungi and slime forming bacteria in recirculating cooling water systems; to inhibit bacterial and fungal growth in epoxy flooring compounds; to inhibit the growth of slime forming bacteria and fungi in pulp and paper mill process water systems and for the protection of wood and wood products (such as utility poles, piling timbers and other large solid or laminated wood products) against fungal decay.

Formulators using this product are responsible for obtaining EPA registration for their formulated product and for providing appropriate data.

This product is not to be used to formulate products designed for use in once-through cooling systems.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**STORAGE**

Store this product in a dry, cool place below 95 degrees Fahrenheit. Material reacts non-violently with moisture releasing fumigant vapors. Keep container tightly sealed when not in use. Do not reuse empty container. Keep this product and its vapors away from desirable plants, seeds, fertilizers, insecticides and other agricultural chemicals as plant injury may result from contamination.

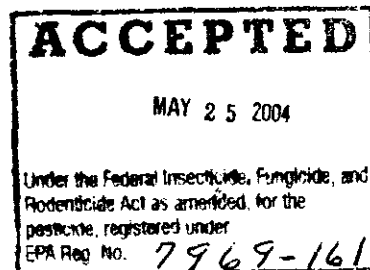
