Do not apply the contents in the individual compartments of the Rezult container in any combination other than a 1:1 ratio.

## **General Information**

Rezult \*B Herbicide\* is intended for use as part of a weed management program in dry peas in the above listed states. When applied as directed, Rezult will control many annual grasses and broadleaf weeds. Refer to the label for Rezult for a complete list of weeds controlled.

**Rezult** is effective through posternergence contact and systemic activity. Weeds must be thoroughly covered with spray. Large crop-and weed-leaf

canopies shelter smaller weeds and prevent adequate spray coverage.

# **Application Information**

#### Method

**Rezult** may be applied by ground or by air. Do not apply through any type of irrigation system. Refer to the label for **Rezult** for specific instructions for both ground and aerial applications.

#### Timing

**Dry peas:** Apply **Rezult** early postemergence after dry peas have at least three (3) pairs of leaves (4 nodes). Applications before dry peas have at least three (3) pairs of leaves (4 nodes) may result in severe crop injury.

**Weeds:** Apply **Rezult** early postemergence to actively growing weeds before they reach the maximum height listed on the label for **Rezult**.

In Western irrigated dry peas areas, it may be necessary to irrigate prior to application of **Rezult** to ensure that weeds are actively growing. Weeds that are growing under moisture stress are not actively growing and will not be satisfactorily cofntrolled. In this irrigated area, avoid applying **Rezult** during prolonged periods of cold weather (day temperature below 75° F and and night temperature below 55° F for 2-5 days) because weed control may be reduced.

#### Rates

Use the entire contents of this container to treat 5 acres. This is equivalent to 3.2 pints of **Rezult** per acre. Apply **Rezult** early postamergence to actively growing weeds. **Rezult** can be applied at a maximum total rate of 3.2 pints per acre. Do not

apply more than 3.2 pints per acre of **Rezult**® **Herbicide** in a single season.

#### Additives:

Always use 1-2 quarts per acre of UAN solution (28%, 30%, or 32%) or 1-2 pounds per acre of AMS <u>and</u> 1 pint per acre of crop oil concentrate when applying **Rezult**.

Do not apply **Rezult** to dry peas under stress due to lack of moisture, previous herbicide injury, mechanical injury, or cold temperatures, as crop injury may result.

Do not apply to weeds under stress, such as stress due to lack of moisture, previous herbicide injury, mechanical injury or cold temperatures, as unsatisfactory control could result.

Do not apply if rainfall or irrigation is expected within one hour following application.

Do not apply **Rezult** to dry peas within 30 days of harvest.

Do not apply **Rezult** to dry peas under stress from root rot.

Do not apply **Rezult** to dry peas until peas have at least three (3) pairs of leaves (4 nodes).

Do not apply more than a total of 3.2 pints of **Rezult** per acre in one season.

Do not apply more than a total of 2 pounds of bentazon active ingredient (a.i.) from all sources per acre per calendar year.

Do not apply the contents in the individual compartments of the Rezult container in any combination other than a 1:1 ratio.
