The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable with the following condition:

To support the submitted field trial and processing studies, the following storage stability data are required which demonstrate the stability of metaflumizone (E and Z isomers) and M320I04: grapes - 4.8 months; citrus fruit - 5.6 months; almond hulls - 6.5 months; and almond nutmeat - 5.8 months. These data must be submitted within 18 months from the date of this letter.

A stamped copy of the label is enclosed for your records. Please submit two copies of your final printed labeling before you release the product for shipment. Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). 
