On behalf of BASF Corporation I am submitting Notification of changes to the Master label for PTM Insecticide as allowed by PR-Notice 2007-4 and 98-10.

These are changes to the previous Master label that I submitted by Notification on Jul. 17, 2007 and were acknowledged by Linda Arrington on Aug. 24, 2007.

All changes are highlighted for your reference.

This notification is consistent with the guidance in PR Notice 2007-4 and the requirements of EPA's regulations at 40 CFR §§ 156.10, 156.140, 156.144, 156.146, and 156.156. No other changes have been made to the labeling or the Confidential Statement of Formula for this product. I understand that it is a violation of 18 U.S.C. AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides.

It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on the label about personal protective equipment and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Triple rinse or pressure rinse container (or equivalent) promptly after emptying; then offer for recycling, if available, or reconditioning, if appropriate, or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

Triple rinse containers small enough to shake (capacity ≤ 5 gallons) as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank, or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment or mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank, or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

GENERAL INSTRUCTIONS

For application by injection to soil at the base of pine trees.

USE RESTRICTIONS

Make one application per year. **DO NOT** apply more than 21 fl oz (0.13 lb ai) **PTM™ Insecticide** per acre per year.

DO NOT apply this product through any kind of irrigation system.

DO NOT apply within 20 yards (in New York State, **DO NOT** apply within 100 feet or 33 yards) of lakes, reservoirs, rivers, permanent streams, marshes, natural ponds, estuaries, commercial aquaculture facilities or other bodies of water that convey water to these areas. Protection of aquatic areas may be enhanced by maintaining all or a portion of this buffer in vegetative cover.

DO NOT apply to trees raised for pine nuts.

Apply only as a soil injection. **DO NOT** apply to the soil surface.

PREPARING DILUTION FOR APPLICATION

Prior to mixing, remove oil, rust, scale, pesticide residues and foreign matter from application equipment including the strainer. Flush with clean water. Use 50 mesh screens or equivalent in application system.

Fill tank with approximately 1/2 the needed volume of water and start agitation if available. Pour measured amount of **PTM Insecticide** into tank. Add remaining water needed to make the final dilution.

Small handheld or backpack applicator tanks should be shaken after filling and before each application to ensure that the active ingredient is evenly suspended in the mixture. Tank lids must be sufficiently tight before shaking to avoid spillage.

Applicator tanks too large to manually shake should be equipped with a sparge tube agitator. Alternative agitator designs may be used if they can adequately cleanse the bottom of the tank and provide sufficient agitation required for product mixing. Approximately 10% of the tank capacity should be pumped per minute back into the tank through the agitator. Agitate to ensure thorough mixing. Periodic agitation of the final dilution is important to keep the active ingredient evenly suspended in the mixture.

PTM™ Insecticide can be tank mixed in accordance with the most restrictive of label limitations and precautions. No label dosage rates should be exceeded. This product cannot be mixed with any product whose label

contains a prohibition against such mixing. If tank mixes with other products are to be used, evaluate tank mix compatibility with **PTM Insecticide** in a small container before mixing larger quantities in the application tank.

PESTS CONTROLLED

Nantucket pine tip moth (*Rhyacionia frustrana*) and pine bark aphids (*Cinara* spp.)

APPLICATION

Apply a dilution of water and 21 fl oz **PTM Insecticide** per acre at the time of planting or soon after planting. Spot treat by injecting an amount of dilution at least 3 inches below ground into the rooting zone of each pine seedling. Divide the total number of target trees to be treated per acre by 21 fl oz to obtain the amount of **PTM Insecticide** dilution to apply per tree. Dilute the required amount of fipronil with water to apply between 0.1 and 1.0 fl oz of total dilution per tree.
