  - a. Storage Stability (830.6317) and Corrosion Characteristics (830.6320) studies.
  - An immunotoxicity study (Guideline No. 870.7800). If new uses are submitted before 11/30/2012, this study must be submitted with those new uses.
  - c. Method validation data must be submitted for Method FAMS 105-01 reflecting fortifications at 4.5 ppm for grapes, and at both the LOQ (0.05 ppm) and 17 ppm for raisins.
  - d. Radiovalidation data are required to demonstrate that Method FAMS 105-01 adequately recovers weathered residues of metrafenone from grapes.
