



## Directions For Use

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

**Only for repackaging into herbicides for the following uses:** 1) alfalfa, birdsfoot trefoil, sainfoin (dry and undried); apricot; artichoke; globe; asparagus; avocado (nonbearing); beans (dry, succulent); beet (garden); blueberry; brassica vegetables; bulb vegetables; caneberrries; canola/crambe/rapeseed; carrot; cherries (sweet and sour); citrus; clover; corn (Poast Protected™ field & sweet); cotton; cranberry; cucurbit vegetables; date (nonbearing); deciduous trees; nonfood crop areas; fallow land; fescue (tall); fig (nonbearing); flax; fruiting vegetables; grape; head and petiole type vegetables; horseradish; leafy vegetables; gentil; ligonberry, salal, juneberry; nectarine; olives (nonbearing); orchard floor middles; peach; peanut; peas (dry, succulent); pistachio; plum (nonbearing); pome fruits; pomegranate (nonbearing); potato; prune (nonbearing); tuberous and corm vegetables; safflower; set asid conservation land; soybean; strawberry; sugar beet; sunflower; tobacco; tree nuts; 2) uses for which U.S. EPA has accepted the required data or citations of data that the formulator has submitted in support of registration; and 3) uses for experimental purposes that are in compliance with U.S. EPA requirements. ## Storage and Disposal

Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank, or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. **Triple rinse containers too large to shake (capacity > 5 gallons) as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank, or store rinsate for later use or disposal. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank, or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.
