

**Application Directions.** For optimal disease control, begin applications of **Merivon** prior to disease development and continue on a 7 to 14 day interval if conditions are conducive for disease development. Use the higher rate and shorter interval when disease pressure is high.

Applications using drip irrigation systems may provide disease suppression. The level and consistency of suppression from drip line applications varies with the soil type, level of inoculum, irrigation volumes, environment and other factors. See your local BASF representative for details on drip irrigation use in your area.

\*For applications based on dilute volume, plants should be sprayed to runoff. Apply a minimum of 20 gallons of spray volume per acre, and increase the spray volume as the plants grow during the season. DO NOT mix Merivon with the following products:

- Emulsifiable concentrate (EC) formulation or solvent-based formulation products.
- Crop oil concentrate (COC), methylated seed oil (MSO), organosilicone (OS) or MSO/OS blended adjuvant products.
