#### Agricultural Use Requirements

- Storage: Store in original container. Keep container closed. Store in an area that is out of reach of children and animals, away from food, feedstuffs, fertilizers and seed. Protect from frost and freezing.
- Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

#### Container Disposal

Non-Returnable Containers: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

Returnable-Refillable Containers: After use, return the container to the point of purchase or designated locations. This container must only be refilled with CHARTER\* Fungicide Seed Treatment. Do not reuse container for any other purpose. Prior to refilling, inspect thoroughly for damage such as cracks, punctures, abrasions, and damaged or worn out treads on closure devices. Check for leaks after refilling and before transportation. Do not refill or transport damaged or leaking containers. If the container is not being refilled, return it to the point of purchase.

# I. General Information

CHARTER is a liquid seed treatment used for the control of true loose smut, false loose smut and covered smut in barley, and loose smut and common bunt in wheat. CHARTER will generally increase emergence and plant stands by controlling seedling blights. CHARTER will also suppress' early season infections caused by Fusarium Crown and Root Rot, and control seed rot and seed-borne seedling blight caused by Fusarium sp.

<sup>1</sup>Suppression is defined as sub-optimal control which is still of commercial benefit.

RATE: 3.1 fluid ounces of product/100 pounds of seed. 2.5 gallons of product will treat:

# **Method Of Application**

Seed should be well conditioned and free of chaff before treating with **CHARTER**. Treated seed should not require drying after treatment and can be stored or bagged immediately (provided excessive slurry volumes are not applied to the seed). **CHARTER** may be applied using standard commercial seed treatment equipment (such as, but not limited to, slurry or mist-type equipment) or on-farm seed treatment equipment. **CHARTER** may also be used in "On the Go" type air seeder treatment systems.

CHARTER should be applied to wheat and barley at the rate of 3.1 fluid ounces of product per 100 pounds of seed. Thorough seed coverage and proper application equipment calibration is essential for good disease control. To achieve thorough coverage CHARTER may be diluted with water if needed into a slury. Consult the specific equipment manufacturer for slurry recommendations and calibrations. This product is not intended for direct application into a planter box.

# **Use Restrictions:**

- Do not use treated seed for food, feed or oil processing.
- Do not store CHARTER<sup>®</sup> Fungicide Seed Treatment near feed or foodstuffs.
- Do not contaminate feed or foodstuffs.
- Do not contaminate domestic or irrigation waters.
- Do not plant any crop not listed on this label in soil treated with CHARTER within 30 days after planting treated seed.

#### TREATED SEED MUST BE LABELED AS FOLLOWS:

"This seed has been treated with **CHARTER** containing triticonazole. Do not use for food, feed or oil processing. Do not plant any crop not listed on this label in soil treated with **CHARTER** within 30 days after planting treated seed". The date of treatment must also be included on the treated seed label.

Do not store treated seed for more than 18 months. Treated seed stored for periods in excess of 18 months may decrease in germination at a faster rate than untreated seed. Treated seed stored for more than 6 months should be tested for germination before planting.

Thoroughly clean auger after handling treated seed before using same auger for handling commercial or feed grains.

Leftover treated seed should not be stored where there is a chance of it becoming mixed with untreated seed. Store treated seed in cool, dry conditions.
