Only for formulation or repackaging into fungicides for the following uses: 1) terrestrial foliar crop uses on alfalfa, barley, berries and small fruits, brassica leafy vegetables, bulb vegetables, citrus fruits, corn (all types), cotton, cucurbit vegetables, dried shelled peas and beans, edible-podded legume vegetables, fruiting vegetables, grapes, grass grown for seed, fodder, straw and hay, leafy vegetables, oat, oilseed crops (including flax seed, rapeseed and sunflower), peanut, root vegetables, rye, soybean, sorghum and millet, strawberries, sugar beet, sugarcane, tree nuts, tuberous and corn vegetables (including potato), wheat and triticale; 2) seed treatment use on barley, brassica vegetables, bulb vegetables, corn, cotton, cucurbit vegetables, dried shelled peas and beans, edible podded legume vegetables, leafy vegetables, oat, oilseed crops (including flax seed, rapeseed and sunflower), peanut, root and tuber vegetables, rye, sorghum, soybean, succulent shelled peas and beans, sugar beet, wheat and triticale seed; 3) turfgrass use sites including golf courses, residential, institutional, commercial, and municipal lawns, parks, recreational areas including sports and athletic fields, cemeteries, and sod farms that are approved by the EPA; 4) ornamental use sites including containers, greenhouses, lathhouses, and shadehouses, outdoor nurseries (including container, bench, flat, plug, bed-grown or field-grown ornamentals), forest and conifer nurseries, and plantations, retail nurseries, and ornamentals found in interiorscapes, golf courses, recreational landscapes, and residential and commercial landscapes; 5) uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration; and 6) uses for experimental purposes that are in compliance with USEPA requirements. ### Storage and Disposal

Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank, or store rinsate for later use or disposal. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank, or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Dispose of rinsate in compliance with state and local regulations for pesticide products.
