## Product Information

---

This product is a ready-to-use insecticide formulation. When dispensed, the formulation rapidly expands generating a dry foam with an expansion ratio of approximately 30:1, with 1 ounce (weight) of product being dispensed in approximately 5 seconds, producing about 1 quart of foam. One can produces approximately 5 gallons of finished foam.

This product can be applied in and around commercial and residential structures as well as structural and non-structural elements that are subject to attack by, or provide harborage to, these insects. Applications can be made from the interior and/or exterior. Drilling of hole(s) may be required to access galleries or harborages. Treatment of insect harborages associated with trees, shrubs, utility poles, fences, bridges, landscape timbers, under slabs or other non-structural elements is permitted.

**DO NOT** use this product as the sole source of control for active, structural infestations by subterranean termites; the purpose of this application is to kill workers or winged reproductive forms of termites which are present at the time of treatment. It is not intended to provide structural pest control. It is not a substitute for mechanical alteration, soil and foundation treatment, but merely a supplement. For active, structural infestations by subterranean termites, this product can only be used to supplement a federally registered conventional product that is registered as a sole source for termite control. This product will not eliminate termite infestations or provide protection against future infestations.

## Application Instructions

---

When using an actuator not already attached to the can, use only a BASF supplied or approved [actuator/equipment]. Remove the outer cap and snap the actuator into place. Remove the finger pad cover. After using, replace the finger pad cover. When the can is empty, remove the actuator from the can and use it on another can of this product.

The termites should be contacted directly by the foam.

### Reapplication Interval

Only apply this product to previously treated sites if activity is found  $\geq$  30 days after the previous application.

## Indoor Application Instructions

---

Apply to galleries, channels, damaged wood, harborages between structural elements, or within construction voids where termites are known or suspected (unexposed wooden elements inside wall voids, in and around bath traps, shower voids, pipe chases, utility penetrations, and other probable sites of entry or harborage).

### Carpenter Ants

This product kills carpenter ants indoors on non-porous surfaces only. Foam up to a 6 inch length of the trail. Foam must dissipate or be removed before the applicator leaves the area.

## Food/Feed Handling Establishments

Food/feed handling establishments are places other than private residences in which food is held, processed, prepared, or served, including those operating under the Federal meat, poultry, shell egg grading, and egg products inspection programs.
