This product may be used in conjunction with residual insecticides such as those containing abamectin B₁ (e.g., **Avert® DF Dry Flowable Cockroach Bait**), chlorfenapyr (e.g., **PT® Phantom® II Pressurized Insecticide** and **Phantom® Termiticide-Insecticide**), and dinotefuran (e.g., **Alpine® WSG Water Soluble Granule Insecticide** and **PT® Alpine® Pressurized Insecticide**). **DO NOT** use this product with other products when the labels for the other products prohibit such use.

If staining is a concern, test by applying in a small, inconspicuous area before applying to a highly visible portion of the surface in question.

Application Instructions

Remove cap from tip of applicator tube, and apply gel as a pea-sized bead.

- Low to moderate infestation - Approximately 10 beads per 100 square feet are recommended.
- More severe infestation - Approximately 20 beads per 100 square feet are recommended.

This product may be placed on top of or prior to non-repellent insecticide applications. This product may not adhere to surfaces that are dusty or greasy. Reapply as needed. Unwanted bead placements can be removed and discarded.

Spot Treatment

Concentrate bead placements in areas of German cockroach nymph traffic and suspected harborage.

Crack & Crevice® Treatment

Inject into cracks and crevices or in voids where German cockroach nymphs may find harborage such as along walls or floors, under sinks and countertops, within or near garbage collection areas and crawl spaces.
