

- For vegetation control and management in non-agricultural (noncropland) areas.
- For control of weeds and grasses on golf courses, in native grass areas, in ornamental production, for landscaping in commercial/residential/industrial areas, and in conifer/hardwood/Christmas tree production areas (including nurseries and plantations).
- For weed control in citrus fruit (crop group 10-10); pome fruit (crop group 11-10); stone fruit (crop group 12-12); berries; canola; corn (field and sweet), cotton, grapes, soybeans, sugar beets, and tree nuts (crop group 14-12), including pistachios and olives.
