Storage and Disposal

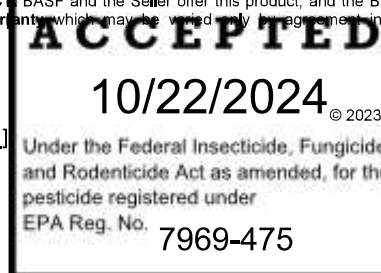
