Do not spray bait gel. Avoid placing gel on surfaces freshly treated with insecticide(s).

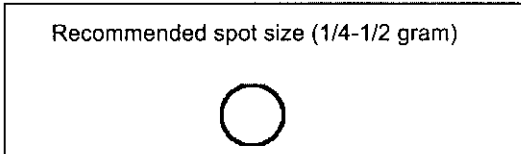
**What It Controls**

Sweet- and grease-eating ants, such as, but not limited to, Argentine, big-headed, odorous house, carpenter, and pyramid ants.

**How to Apply**

Gel should be placed as spots in cracks and crevices. Make many spots or dabs of gel where you see ants foraging and entering structure. Do not place gel in direct sunlight.

Gel should not be visible on vertical surfaces; it may drip if exposed to heat.



**Indoors for ant control:** Place gel in cracks and crevices in areas where ants are seen or suspected to be active. (such as, under sinks, stoves, refrigerators and cabinets, wall voids, cracks and crevices in kitchen, bathroom, under sink, window sills, screen vents, garage, attic, and crawl spaces). Do not place bait in locations that are frequently washed. Do not treat food preparation surfaces. Do not use this product in or on electrical equipment where possibility of a shock hazard exists. Product may stain textiles and clothing.

**Outdoors for ant control:** Place spots near ant colonies and along trails near structures. This bait may be used adjacent to homes, cabins, stores, apartment buildings, restaurants, trailers, and warehouses.
