3. Submit one year Storage Stability data (830.6317) within 18 months from the date of this registration.
4. Make the following changes to the label:
 - a. Revise the EPA Registration Number to read, "EPA Reg. No. 8033-100".
 - b. Delete "other nuisance ants" wherever they appear on the label.
 - c. For acute toxicity category IV, no Precautionary/First Aid statements are required (optional statements) but the "Harmful if swallowed or adsorbed through the skin" and wash after handling" statements (already on the label) are recommended.

For control of sweet- and grease-eating ants:

~~As such as, but not limited to, acrobat, Argentine, big-headed, carpenter, cornfield, crazy, field, ghost, honey, little black, odorous house, pavement, pharaoh, pyramid, rove, thief, and velvety tree, and other nuisance ants.~~

For indoor and outdoor use. Place stations by ant trails or close to areas where ants are present. Do not place stations in areas that have been recently sprayed with insecticide or contaminated with foggers, and do not spray insecticide over stations. If you have recently sprayed, remove the dead ants and thoroughly clean the area before placing stations.

Puncture (with pencil or pen tip) pre-cut hole in hinged end of station when ready for use. The hole may be 1/8 to 1/4 inch diameter. Place station so gel bait does not leak out. A second hole for ant access may be made on the unhinged end of the station.

~~Place sStations should be placed where ants are seen or act activity is suspected to occur. (For carpenter ant colonies, locate nests and place stations near associated trails.)~~ Place stations next to cracks, crevices, corners and any out of the way place, such as under and behind kitchen appliances, along baseboards, under sinks, in pantry, around pipes and water heater, window and doorframes, and in the garage, attic, or crawl space.
