It is a violation of Federal law to use this product in a manner inconsistent with labeling.

KA-22 is used to control fungal degradation of water-based emulsifiable cutting fluids and during cleaning operations. It should be added to the fluid at a rate that will provide 150 to 200 parts per million of KA-22 (weight/weight) with water. KA-22 can be added to the concentrate before dilution. Higher concentrations are needed for growth on the inside walls of the fluid storage tanks, higher concentrations are needed. For this use, it is recommended that KA-22 be diluted to a concentration of 1000 to 1250 parts per million.
