

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labelling.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four containers high. Leaking or damaged containers should be placed in overpack drums for disposal. Spills should be collected and disposed of in a sanitary landfill. Keep container closed when not in use. Store away from fertilizers, feed, seed, and insecticides.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of liner in a sanitary landfill or by incineration if allowed by State and local authorities. If drum is contaminated and cannot be reused, dispose of in the same manner.

For general vegetation control along fences, buildings and railroad tracks, apply at the rate of 1# to 3# per 100 sq. ft.

Although this may be applied anytime during active vegetation growth, BEST time to apply is in early spring, when vegetation begins active growth. Sufficient moisture (either by sprinkling or natural rainfall) is necessary to carry this material into root zone of the vegetation to be controlled. Once area is under control, lighter applications annually (1/2# to 1# per 100 sq. ft.) will keep area free of vegetation. Do not apply when ground is frozen.
