DIRECTIONS FOR USE

Use 4 to 6 quarts per acre (3 to 5 ounces in 1-2 gallons water, per 1,000 sq. ft.) in sufficient water for uniform spray coverage. Repeat applications may be necessary. Use lower rate for easy-to-kill species, i.e. dandelion and plantains. Use higher rate for more effective general control of weeds.

Use preferably in the spring or fall when weeds are actively growing. The killing action is more rapid when applied on warm clear sunny days than when weather is cool, cloudy or wet.

NOTE: Do not use on newly seeded lawns. Do not mow turf for several days before or after treatment. In some areas Dichondra, clover, bent grasses, carpet buffalo, and St. Augustine grasses may be injured.
