This product is specifically designed as a mosquito breeding control. It is effective against mosquito larvae in standing water, intermittently flooded areas, stagnant water, temporary rain pools, and log ponds.

Apply Liquid Mosquito Larvacide to the water surface by aircraft or ground spray equipment at the rate of 3 gallons or less per acre, assuring an even coverage of the entire area. In severe cases, such as highly polluted waters or waters of high organic content, rates may be increased up to a maximum of 5 gallons per acre.
