

# NON-SELECTIVE HERBICIDE

This product is a specially formulated non-selective herbicide for controlling a wide range of annual and perennial weeds and grasses on such non-cropland areas as parking lots, fence rows, railroad sidings, rights of way, drainage ditch banks, and other similar areas. Apply undiluted as a spray to obtain sterile, bare ground. Control of vegetation will vary with the amount of this herbicide applied, rainfall, soil type, and other conditions.

## DIRECTIONS

This product may be applied at any time of the year, EXCEPT when ground is frozen. Best results are obtained after vegetation has emerged, in late spring or early summer. Use power sprayers, compressed air hand sprayers, or an ordinary sprinkling can. No dilution or agitation is required.

Uniformly spray 2½-3 gallons per 1,000 sq. ft. of soil surface, (100-120 gal. per acre). Thoroughly wet all foliage to insure contact action. Where vegetation is tall and dense, use 5 gallons per 1,000 sq. ft. (200 gals. per acre). For control of hard-to-kill perennial weeds and grasses such as Johnsongrass, Bindweed, and Wild Carrot, use 8-12 gallons per 1,000 sq. ft. Although this herbicide has considerable activity through foliar contact, much of its activity is through the roots and, therefore, adequate rainfall to move the chemical into the root zone is necessary.

Under conditions where the rainfall is high and the growing season long, a second application may be necessary to maintain a weed-free soil surface.
