

#### TOP GROWTH KILLER

Mix one pint in one gallon with water OR ½ pint in Kerosene, Diesel Oil or old crankcase oil. Spray to wet plants thoroughly. If growth has been permitted to become high and dense, a repeat application may be necessary after 10 to 14 days to cover any green growth originally missed. PERENNIAL WEEDS with deep roots will require retreatment at 30-60 day intervals until the roots have lost their vitality.

#### PREVENTION OF NEW WEEDS

Pre-emergence control of new weed seed germination depends on heavy covering of the soil surface. For best results the area to be treated should be first cultivated relatively clean or a final soil treatment given after top growth has been killed as above.

USE one pint per gallon in water and wet soil thoroughly with sprayer or sprinkling can. Each gallon of mix should cover approximately 50 square feet. This dose can be reduced in half if area has been sprayed twice already to clear heavy top growth.

Repeat as necessary. This will normally be at one year intervals, but may be more or less depending on rainfall, soil type and kind of weeds. Repeat when new weeds are not more than one or two inches high.

**BEFORE SURFACING:** Use this treatment before topping drives, walks, patios, etc. with asphalt, brick, concrete, crushed rock, etc.

**CAUTION:** Do not allow spray drift onto cultivated plants. Use a low pressure coarse spray and apply when there is no wind. Do not apply in flower or vegetable beds or under drip line of trees or shrubs. Shallow rooted plants may be injured or killed. Do Not Flood area after spraying or apply where rains may wash the herbicide into a cultivated area. Do not contaminate water used for irrigation or domestic purposes.

**CAUTION:** Harmful if swallowed, inhaled or absorbed through the skin. May cause severe skin irritation. In case of skin contact wash promptly with soap and water. In case of eye contact flush eye 15 minutes with running water and get medical attention. Do not store near or contaminate feed or foodstuffs. Do not apply around dairy barns or poultry houses. When empty, wash container thoroughly and destroy. Do not transfer to unlabelled container.
