

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labelling.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack more than five drums high. Drums should be opened in well-ventilated areas. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use. Do not store near fertilizers, seeds, insecticides, or fungicides.

This product may be applied at any time of the year, except when ground is frozen. Best results are obtained after vegetation has emerged, in late spring or early summer. Use power sprayers, compressed air hand sprayers, or an ordinary sprinkling can. No dilution or agitation is required.

Uniformly spray 2 1/2-3 gallons per 1,000 sq. ft. of soil surface, (100-120 gal. per acre). Thoroughly wet all foliage to insure contact action. Where vegetation is tall and dense, use 3 gallons per 1,000 sq. ft. (200 gals. per acre). For control of hard-to-kill perennial weeds and grasses such as Johnsongrass, Bindweed, and Wild Carrot, use 8-12 gallons per 1,000 sq. ft. Although this herbicide has considerable activity through foliar contact, much of its activity is through the roots and, therefore, adequate rainfall to move the chemical into the root zone is necessary.

Under conditions where the rainfall is high and the growing season long, a second application may be necessary to maintain a weed-free soil surface.
