This product should not be applied directly but should be diluted by adding 7 gallons of the concentrate to 36.5 gallons of phytotoxic oil vehicle and mix thoroughly. To control most weeds and grasses for extended periods on non-cropland areas such as industrial plant sites, parking lots, loading ramps and around storage buildings and similar non-crop areas, apply 1 to 4 gallons per 1000 square feet of the diluted liquid, after the most predominant weeds have emerged, when weeds are young and actively growing. No agitation is required. The diluted liquid can be applied with standard spray equipment. For treating small areas, a tank type hand sprayer and sprinkling can may be used.

**NOTE:** Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to use of this product in their particular area.

**IMPORTANT:** Do not apply directly to, or otherwise permit this product or its diluted form to contact susceptible plants as this product may injure cotton, beans, peas, grapes, flowers, fruit trees, ornamentals, or other desirable plants.
