

GENERAL CLASSIFICATION ***

It is a vigittion of Federal law to use this " product in a manner-inconsistent with its labeling.

To control algae and bacterial slimes use BACTRON KM-12 MtCROBIOCIDE as directed. For best results, slug feed. The frequency of addition of microbiocide needed depends on many factors. To optimize your use of BACTRON KM-12 MICROBIOCIDE, follow this procedure.

Recirculating Cooling Towers:

Initially use 16-24 fluid ounces per 1000 gallons of water to be treated (20-30 ppm active quaternary). Repeat the initial dose every seven days or increase the frequency, if needed

When the above treatment level is successful, use 14-18 fluid ounces per 1000 gallons of water to maximize efficiency. Repeat weekly as needed.

Cooling tower waters that are inherently low in algae growth and bacteria count may be adequately controlled by the lower range of these dosages. Slug feed every seven days.

Oil Field Water Flood or Salt Water Disposal Systems.

For the control of slime forming and sulfate reducing bacteria in oil field water flood or salt water disposal systems, add 20-30 ppm (active) BACTRON KM-12 MICROBIOCIDE (7-10-3 gallons per 1000 barrels of water) continuously. Levels for effective control will vary depending on conditions at the site.
