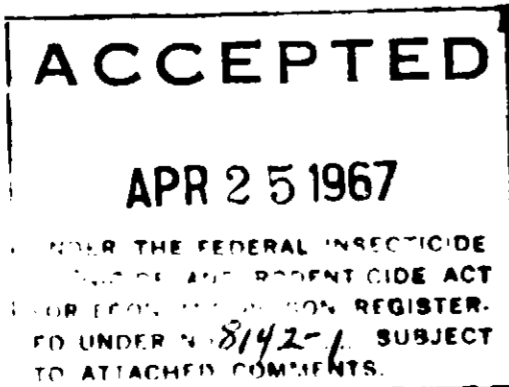

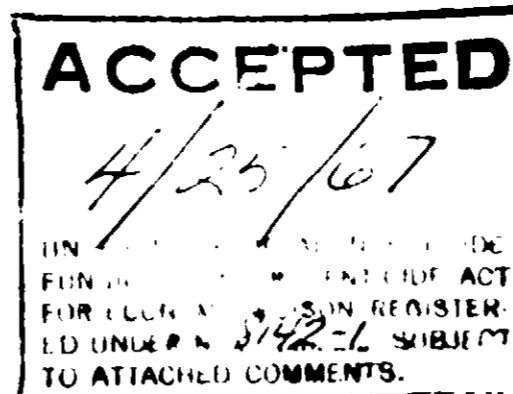

DIRECTIONS FOR USE

FOR DAIRY CATTLE, BEEF ANIMALS To protect dairy and beef animals from face flies, house flies, stable flies, mosquitoes and gnats, spray the animal's daily using 1 to 2 ounces of this product per head. Cover the animals with spray with particular attention to back, flanks and legs. Do not soak the skin or wet the hide. Experience indicates that two applications of 1 ounce of this product morning and night give outstanding control of the above pests. This product may be applied as a mist spray with a hand or automatic sprayer. Do not apply in excess of 2 fluid ounces per animal per day. When a barn fogger is used, fog 1 pint per 8,000 feet of enclosure (40' length x 20' width x 10' height) for controlling flies, mosquitoes and gnats. Let fog settle before milking. **DO NOT** use this solution for fogging purposes in areas where animals have received direct application within 8 hours.

SUPPLEMENTAL DIRECTIONS: By diluting one part Vapona Insecticide Fly Spray with one part of fuel oil, diesel oil or kerosene and applying as a coarse spray (sprinkling can) an inexpensive contact and vapor spray is obtained to control flies, gnats, mosquitoes, roaches, ants, fleas, sowbugs and brown dog ticks. Apply this dilute solution as a coarse, wet spray at the rate of one quart per 1,000 square feet. For milk sheds, stables, livestock barns, loafing sheds, pig pens and outdoor areas, treat around doorways, feed storage rooms, alleyways and window sills. Do not contaminate milk or milk handling equipment. In poultry houses, apply to manure, window sills, outside of penned enclosures and on floor of feed storage rooms.

DOG KENNELS: In treating dog kennels, apply to outside of dog runways, window sills and ledges. For control of fleas and brown dog ticks, apply 1 quart of this dilute solution per 1,000 square feet of area.

FLY MAGGOTS: To control fly maggots in maggot breeding areas, such as garbage dumps and manure piles, apply one to two quarts of dilute solution per 100 square feet of area.

OUTDOOR AREAS: To treat outdoor living areas, picnic grounds, patios, loading docks, outdoor latrine, parking areas, refuse areas, around service stations, open air drive-ins, ice cream stands, garbage collection and disposal areas for controlling flies, mosquitoes and gnats, use 1 quart of diluted solution per 1,000 square feet.
