
The labeling submitted with your application is acceptable provided that you revise the label in accordance with the following comment, before you release the product for shipment bearing the amended labeling:

Allow to remain 10 minutes. 5. Flush and rinse out applicator. A preliminary cleaning is necessary for the removal of gross filth prior to disinfection.

Recommended for use in commercial and industrial buildings, schools, manufacturing plants, hotels and motels.

Do not use on sinks, bath tubs, or other porcelain enameled surfaces. Use of this Toilet Bowl Cleaner on other than vitreous ware is done at user's risk. Rinse empty container thoroughly with water and discard it.

DANGER: CORROSIVE: produces chemical burns.
