Do not top coat with clear finishes.

B. PREPARE THE SURFACE CAREFULLY

Ma's sure surface is clean, dry and free of loose mallirial. New wood with surface glaze must be sanded to allow for penetration.

Do not use over pressure treated or dip treated new wood.

C. APPLY PROPERLY

Because this product contains a preservative, stir thoroughly before and during application. Dipping is the preferred method for treating wood which will be in contact with the ground. Apply liberally by brush, roller, spray or dip. Soak end grain thoroughly. Do not allow excess material to pool or puddle on surface. If used prior to priming, apply one coat. Two coats if to be left clear and apply second coat before first coat is dry, or wait 24 hours if wet-on-wet is not possible. If surface is to be painted, use alkyd primer before applying finish coat.

Dries to touch in three to four hours. Wait 24 to 48 hours before painting.

Do not apply when temperature is below 40° F.

D. SPREADING RATE

Approximately 150 to 250 sq. ft. per gallon per coat depending on surface condition and application method.
