

GENERAL INFORMATION

PREFORAN (C-6989) 15 G Herbicide is a granular product effective for the control of certain annual grass and broadleaf weeds when applied preemergence to soybeans. PREFORAN may be applied as a broadcast or as a band treatment to the surface of the soil at planting or at any time preemergence to the crops and weeds.

The seedbed should be well prepared and as free as possible from trash and clods. Best results are obtained when granules lie undisturbed on an even flat surface not subject to shifting by wind or rain. Do not soil incorporate PREFORAN (C-6989) 15 G Herbicide.

Use only one application to the crop during any one year. Do not follow the treated crop within the same year with any other crops except soybeans.

The granular size of this product i 30/60 mesh.

WEED CONTROL

PREFORAN is effective for controlling certain annual grass and broadleaf weeds in soybeans, such as:

APPLICATION DIRECTIONS

Broadcast Treatment — Apply 25 to 30 pounds of PREFORAN 15 G per acrit to the surface of the soil with conventional granular applicator. PREFORAN may be applied at the time of planting soybeans, or at any time preemergence to the crop and weeds.

Band Treatment — A band treatment of PREFORAN is made in the same manner as a broadcast treatment, except proportionately less herbicide is used. For example, for 14-inch band on 42-inch row use 1/3 of the broadcast rate. A minimum band width of 12-14 inches is recommended, which will reduce the need for close cultivation. The following formula may be used to calculate the amount of PREFORAN per acre for band treatment:

Do not cover treated band with soil while cultivating.
