HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

DANGER: Harmful if swallowed. Corrosive; causes eye damage. Do not get in eyes. Avoid inhalation of dust from treated seed. Wear a pesticide respirator jointly approved by the Mining Enforcement and Safety Administration and by the National Institute for Occupational Safety and Health under provisions of 30 CFR Part II. Avoid contact with skin by wearing rubber gloves when treating or handling treated seed. Avoid contact with eyes by wearing safety goggles while handling treated seed. Wash with soap and water after handling and before eating, drinking or smoking. Avoid contamination of feed, food and foodstuffs. Do not graze or cut soybean forage for feed.

Exposed treated seeds may be hazardous to birds and other wildlife. Dispose of all excess treated seeds by burial away from bodies of water.

PRODUCT INFORMATION: AGROSOL Flowable is a ready-to-use seed treatment formulation prepared for commercial seed treaters. When used at the correct dosage rate, AGROSOL Flowable will protect seeds from soil and seed borne diseases that cause damping-off, seed decay, seedling blights and pod and stem blight (*Phomopsis* spp.) during germination and early seedling stages.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labelling.

SHAKE OR STIR WELL BEFORE USING. Use at temperatures above 40°F. Use AGROSOL Flowable in liquid and slurry treaters at the rate of 1.5 fl. oz. per bushel of soybean seed (2.5 fl. oz. per 100 lbs. of soybean seed).

NOTE: The purchaser of this product is responsible for insuring that all seed treated with this product are adequately dyed with a suitable color to prevent its accidental use as food for man or feed for animals. Refer to 21CFR, Part 2.25. Any dye added must be cleared for use under 40 CFR, PART 180.1001.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store above 32°F. Product stored at a lower temperature will reconstitute to satisfactory utility if warmed to approximately 70°F and thoroughly shaken or stirred before use. Store treated seed in a ventilated place away from water, food and feed.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse, then puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.

NOTICE TO BUYER: Seller's guarantee shall be limited to the terms of the label and subject thereto, buyer assumes the risk to persons or property arising from the use or handling of this product and accepts the product on that condition.
